Please verify that we have your correct email address as confirmations, class cancellations and other communication will be done via email.

Class or camp fees are non-refundable. However, fees may be transferred in full to a future class or camp if a written request (e-mail) is received 14 days prior to the start of the class or camp from which you are withdrawing. If we have fewer than 14 days' notice the credit will be minus 25% the cost of your class or camp. Cancellations within 48 hours of a class, camp or workshop are non-refundable/non-transferable. We often turn away students and a last-minute cancellation prevents us from filing the spot. Should Davis Studio need to cancel a class or camp for any reason you will be notified and given a full refund.
